# Northland School Division and Northern Lakes College engage on program opportunities

Northland School Division (NSD) is pleased to be running its 3<sup>rd</sup> Annual Summer Reading Program. The purpose of the program is to provide NSD students with high-quality reading materials they can read over the summer.

"Many of our communities do not have libraries and we want our students to have access to books," Janette Cavanaugh, Division Principal Literacy. "It is well documented in the research that the summer reading slump is significant for many students. Our students deserve the access to these books so that we can mitigate the effect of the summer reading slump. Our teachers, staff, and students work so hard during the school year to raise their

reading levels. We do not want to lose ground."

The Summer Reading Program is funded by Cenovus Energy which covers the cost of books. NSD school communities receive several hundred books to distribute over the summer. Many communities place books in health, youth and recreation facilities. The program is operating in 20 out of 21 NSD school communities and in three Kee Tas Kee Now Tribal Council Education Authority (KTCEA) school communities (Cadotte Lake, Atikameg and Loon River). # NSD central office staff participate in Professional Learning Pebbles Training



On June 29, 2018, Northland School Division central office staff participated in Professional Learning Pebbles Training. The purpose of the training is to ensure staff understand First Nations, Métis and Inuit Foundational Knowledge. The training was facilitated by Indigenous Curriculum Pedagogical Supervisor Terry Lynn Cook. Before returning to the Northland family, Cook worked with the Alberta Teachers' Association as a Walking Together Consultant. She was one of six who helped train educators and school division staff throughout the

province. The information shared during the training includes:

- Awareness: Understanding historical, legal and contextual terminology pertaining to Indigenous peoples.
- Acknowledgment: Understanding the significance of revitalizing First Nations, Métis and Inuit
  cultures as supported by the Truth and Reconciliation Commission of Canada: Calls to Action.
- Atonement: Deepen awareness and knowledge of First Nations, Métis and Inuit beliefs, traditions and practices to advance reconciliation.
- Action: Planning your path to reconciliation.

In addition to discussing the above mentioned topics, central office staff participated in a series of activities to increase awareness. One activity saw staff draw a world view tree on a sheet of paper using felt markers. After drawing the leaves, the trunk and the roots, they wrote words explaining who they are. The other activity saw staff pass around a rock garden. Each person chose a rock from a glass bowl and explained what they think reconciliation is.

The Pebbles Training has been preparing educators for the new professional quality standards, effective September 1, 2019. The new Teaching Quality Standard, which hasn't been updated since 1997, requires staff to apply foundational knowledge about First Nations, Métis and Inuit. In addition, a quality standard has been developed for leaders (principals, vice-principal and central office staff other than the superintendent) and superintendents. Both standards require supporting the application of foundational knowledge about First Nations, Métis and Inuit.

## **BACKGROUND:**

After Policy 19, Appendix B Sexual Orientation and Gender Identity was adopted at the June 21, 2018 Corporate Board meeting, the department came back with the following suggested change to Policy 19, Appendix A Student Code of Conduct so the policies would all be in compliance with the requirements outlined in the Act to Support Gay-Straight Alliances, formerly known as Bill 24.

The two requests for changes are as follows:

- 1. Policy 19 is missing one sentence from Appendix A. Can you add a #8 to Appendix A (see sentence below) without seeking board approval?
  - 8. Support will be provided for students who are impacted by inappropriate behaviour, as well as for students who engage in inappropriate behaviour.
- 2. Although Policy 19 is linked from the NSD homepage, the Appendices A and B are not and need to be as well.

#### **RISK ANALYSIS:**

The risk in not adopting these changes are that we will not be in compliance with legislation.

# STUDENT CODE OF CONDUCT

The Board endorses a set of desirable personal and interpersonal character traits that incorporate universal values common to all religions and ethnic-cultural groups, including respect, integrity, empathy, compassion, independence, cooperation, responsibility and self-control.

Students are expected to learn, practice and develop such personal and interpersonal character traits and to contribute to the development of welcoming, caring, respectful and safe learning environments. Students are further expected to respect diversity and refrain from demonstrating any form of discrimination as set out in the Alberta Human Rights Act, including gender identity and gender expression as set out in the Alberta Bill of Rights. Students are to foster a sense of belonging amongst all students.

Within the aforementioned context, students are expected to pursue academic and cultural studies to maximize their individual potential in becoming self-reliant, responsive and contributing members of society.

# **Specifically**

- 1. In displaying acceptable behaviour, students are expected to:
  - 1.1 Use their abilities and talents to gain maximum learning benefits from their school experiences;
  - 1.2 Contribute to a climate of mutual trust and respect conducive to effective learning, personal development, and social living:
  - 1.3 Co-operate fully with everyone authorized by the Board to provide education programs and other services:
  - 1.4 Comply with all applicable federal, provincial and municipal laws, and the rules of the Division and school:
  - 1.5 Account to their teachers for their conduct:
  - 1.6 Attend school regularly and punctually;
  - 1.7 Use non-violent means to resolve conflict;
  - 1.8 Treat all other students and staff with dignity, respect and fairness at all times;
  - 1.9 Contribute to a learning environment that is free from physical, emotional, and social abuse:
  - 1.10 Take appropriate measures to help those in need; and
  - 1.11 Demonstrate honesty and integrity.
- Students are accountable for demonstrating respect for:
  - 2.1 Authority;
  - 2.2 Others and their property;

- 2.3 School property, equipment and textbooks; and
- 2.4 Differences in ethnicity, race, religion, gender and sexual orientation.
- 3. Students are prohibited from engaging in unacceptable behaviour, whether it occurs within the school building, during the school day or by electronic means.

Examples of such behaviours include, but are not limited to:

- 3.1 Use, possession of, sale, distribution of or active contact with, a weapon on a student's person, in a student's locker or desk, on Board property, or in a vehicle on Board property used by a student or occupied by a student as a passenger;
- 3.2 Threats;
- 3.3 Conduct which endangers others;
- 3.4 Encouraging conduct which endangers or may endanger others;
- 3.5 Encouraging unacceptable conduct;
- 3.6 Use or display of improper, obscene or abusive language;
- 3.7 Distribution or display of offensive messages or pictures;
- 3.8 Theft, including identity theft;
- 3.9 Assault;
- 3.10 Willful damage to school or others' property;
- 3.11 Use, possession of, distribution of, or active contact with, or collection of money for illicit drugs, alcohol, or inhalants in school, on Board property or in the context of any school-related activity:
- 3.12 Attending school or any school-related activity under the influence of illicit drugs, alcohol or inhalants:
- 3.13 Personal or sexual harassment:
- 3.14 Hazing, initiation activities; the formation or the operation of sororities, fraternities, gangs and secret organizations;
- 3.15 Extortion;
- 3.16 Disruptive behaviour, willful disobedience or defiance of authority;
- 3.17 Interfering with the orderly conduct of classes or the school;
- 3.18 Tampering with fire alarms and safety equipment:
- 3.19 Criminal activity;
- 3.20 Contravention of the school's code of conduct;
- 3.21 Workplace violence:
- 3.22 Bullying, including cyber-bullying; and
- 3.23 Inappropriate information technology use.
- 4. Unacceptable student behaviour:
  - 4.1 May be grounds for disciplinary action; and

- 4.2 Provides an opportunity for critical learning in the areas of:
  - 4.2.1 Personal accountability and responsibility;
  - 4.2.2 The development of empathy;
  - 4.2.3 Conflict resolution;
  - 4.2.4 Communication; and
  - 4.2.5 Social skills development.
- 5. When responding to unacceptable student behaviour, the following are to be considered:
  - 5.1 The effect of the student's behaviour upon other students, the staff, the school, and the community;
  - 5.2 The nature of the action or incident that calls for disciplinary or alternative measures;
  - 5.3 The student's previous conduct and previous interventions;
  - 5.4 The student's age, maturity and abilities;
  - 5.5 The impact of proposed action on the student's future behaviour;
  - 5.6 The student's learning needs; and
  - 5.7 Any other information considered appropriate or relevant.
- 6. The consequences of unacceptable behaviour may be:
  - 6.1 Assignment of a student whose behaviour is unacceptable, disruptive or destructive to an alternate supervised location;
  - 6.2 Short term removal of privileges;
  - 6.3 Detention:
  - 6.4 Use of reasonable force as required by way of correction to restrain a student from carrying out a violent or destructive act that could harm the student or others;
  - 6.5 Alternative interventions such as community conferencing or other forms of restorative justice;
  - 6.6 Corrective student transfer;
  - 6.7 Suspension; and
  - 6.8 Recommendation for expulsion.
- 7. Students will contribute, to the greatest extent possible, to a learning environment that is well-ordered, peaceful, safe, non-threatening, and conducive to learning and optimal growth.
- 7.8. Support will be provided for students who are impacted by inappropriate behavior, as well as for students who engage in inappropriate behavior.

#### **BACKGROUND:**

In Policy 2, Role of the Board – Fiscal Accountability, section 5.5 states, "Approve substantive budget adjustments when necessary." A definition of "a substantive" adjustment is needed.

Several sources for information (auditors, other boards) were polled, with mixed results. However, after assessing all the information, this is the recommendation, for definition within AP 500, Budgets:

The Secretary-Treasurer will obtain approval for net increases to the overall budget in the amount of \$125,000 or more at the next board meeting following the discovery of the overage, or the possibility of an overage. This amount equates to 0.2% of the overall budget, and, if the budget increases or decreases, the Secretary-Treasurer may want to review the approval threshold.

# **RISK ANALYSIS:**

The risk for not having a definition is that the board may be expecting to approve different amounts than the administration does. It is important to balance the board's expectation for information and administration's ability to deal with issues as they come up.
