NSD partnering with Peavine Métis Settlement to develop curriculum reflecting local stories & culture

NSD is embarking on an exciting project with the Peavine Métis Settlement. The Board of Trustees directed the Superintendent of Schools Gord Atkinson to work with the settlement to develop curriculum that reflects local Métis stories and culture in Bishop Routhier School.

NSD originally met with the Peavine Métis Settlement to discuss this work on November 6, 2018. Atkinson has directed Area 1 Associate Superintendent Shelley Willier to work on this project with the Bishop Routhier School principal and the community.

2019-2020 School Year Calendar draft accommodates families and division-wide professional learning

The 2019-2020 School Year Calendar draft is geared towards accommodating families and creating time to

host professional development for all staff. A winter break is scheduled during the second week of February (February 10-17, 2020) and spring break is scheduled during the first week of April (April 6-13, 2020). Two dates have been scheduled for division-wide professional learning (PL). The first PL is taking place October 4, 2019 and the second PL is February 13, 2020. The calendar is being circulated in the school communities for feedback and will be brought back to the March 24, 2019 Regular Board Meeting.

Notice of motion for possible school closures at Pelican Mountain School and Calling Lake Outreach School

The Board of Trustees approved a notice of motion regarding the possible school closures of Pelican Mountain School (Sandy Lake) and Calling Lake Outreach School. NSD's school closure policy (Policy 15 - School Closure), the School Act, and Closure of Schools Regulation outline a process for possible school closures. This includes hosting public meetings. The Calling Lake Outreach School meeting is Tuesday, March 19, 2019 and the Pelican Mountain School meeting is Wednesday, March 20, 2019. The public meetings will help NSD understand the reasons why parents are sending their children to other schools and give parents and community members the opportunity to discuss alternative programs and the preferred future for both schools. The Board will vote on the motion no later than the May 24, 2019 Regular Board Meeting.

Board not proceeding with notice of motion for possible school closure at Hillview School



After reviewing the Hillview School Viability Study, the Board of Trustees approved to not proceed with a notice of motion regarding a possible school closure. The trustees noted Hillview School and the East Prairie Métis Settlement have made progress to enhance educational opportunities for students. As part of the NSD and East Prairie Métis Settlement Memorandum of Understanding, a pre-kindergarten program was established to help increase student enrolment. Policies approved by the Board

The Board of Trustees approved:

- Third reading for Policy 5 Appendix A Signing Authority Chart. The chart is a formal process for board approval of contracts, board guidelines for signing contracts and delegation of authority for approval and signing to the superintendent of schools https://www.nsd61.ca/download/152241.
- First Reading for Policy 5 Role of the Board Chair. The policy clarifies the practice of opening and closing a meeting. The proposed change will enable each person to provide opening and closing comments relevant to their culture.

First Quarter Financial Statements approved

The Board of Trustees approved the Unaudited First Quarter Financial Statements for the period of September 1, 2018 to November 30, 2018. The report, presented by Secretary-Treasurer Trudy Rasmuson, shows the division was in a \$2.7 million deficit. However this is a result of not receiving \$2.3 million in revenue yet:

- \$1.25 million of the five year investment grant from Alberta Education.
- \$285,844 of tuition year-end adjustments from First Nations.
- 193,983 of gifts, donations and fundraising.
- The rest relates to the timing of the revenue coming in.

Ward 5 Trustee Louis Cardinal is taking on a new role for the remainder of his electoral term. The Board of Trustees approved the role Board Community Engagement Lead for Cardinal, as a board ad hoc committee in Policy 8. With the transfer of Little Buffalo, Peerless Lake and Kateri (Trout Lake) Schools from NSD to Kee Tas Kee Now Tribal Council Education Authority (KTCEA), the role of the Ward 5 trustee was reduced, as there are no longer any Northland schools within the ward. The role of Board Community Engagement Lead not only gives Cardinal a defined role but also taps into his knowledge and enhances the Board's involvement in

Dr. Ruby Payne presentation highlighted in the Superintendent's Report



Superintendent of Schools Gord Atkinson started out by discussing the special guest who will be speaking to NSD staff on February 13, 2019 in Edmonton. Dr. Ruby Payne is presenting *A Framework for Understanding Poverty*. Atkinson says following the presentation, NSD staff will have consistent messaging with respect to poverty. He talked about his recent get-together with Athabasca Tribal Council. Atkinson said progress has been made on drafting an educational services agreement.

The planning stages have begun on a balanced calendar concept. On September 21, 2018, the Board of Trustees directed the superintendent to explore and develop a

plan, for the Board's consideration, learning calendar and learning program which includes community

engagement and that reflects and honours Indigenous Ways of Knowing and Ways of Being. Atkinson says an update will be provided at the February 15, 2019 Regular Board Meeting.

In November trustees and members of the senior administration met with Honourable Danielle Larivee to discuss ways to better serve students in care. During the meeting, they talked about connecting caseworkers to NSD Family Wellness Workers as a way to ensure students in care are attending school regularly and achieving academic success. Larivee is the Minister of Children Services. On January 10, 2019, Atkinson met with the director of child protective services to address the November conversation with Larivee. The director told Atkinson the discussion is important but right now they are inundated with the current fentanyl situation in Alberta.

Professional Learning & Kindergarten to Grade 12 Numeracy Framework highlighted in the Area 1 Associate Superintendent's Report

In early September, Area 1 Associate Superintendent Shelley Willier discussed building capacity with principals and teachers so they can improve teaching and learning in classrooms, schools and communities. To support this work, principals have been developing a better understanding of the Leadership Quality Standard (LQS) and Curtis Linton's Equity Framework. The LQS will come into effect September 1, 2019. The standard identifies nine competencies which leaders are required to demonstrate. The Equity Framework focuses on leadership, teaching practice and school culture.

This month, Willier showcased the framework in action by highlighting professional learning and events in Area 1. Occupational Health and Safety Gap Analysis presented as information



Occupational Health and Safety (OH & S) Manager Stuart Elle presented an OH & S Gap Analysis for NSD. Elle, who joined NSD in October 2018, began by sharing his previous school division OH & S experience and Bill 30 – An Act to Protect the Health and Well-Being of Working Albertans. The act includes numerous changes to the Alberta Health and Safety Act, Regulation and Code.

Before sharing the analysis, Elle used a space analogy to emphasize the importance of health and safety in schools. Asking trustees to imagine NSD as

a space program, Stuart talked about utilizing the power of "negative thinking", a phrase coined by Retired Canadian Astronaut Chris Hadfield. Elle says the power of negative thinking is a strategy used for identifying risks and planning for worst case scenarios.

Submission of Proposals for Indigenous Languages in Education (ILE) Grants



Director of First Nations, Métis and Inuit Learner Success Lorraine Cardinal-Roy updated the Board of Trustees regarding four proposals NSD submitted for ILE grants. The first proposal, in partnership with Kee Tas Kee Now Tribal Council Education Authority (KTCEA), talks about expanding the professional learning for Indigenous language instructors. The second submission, in partnership with the University of Alberta and KTCEA, would be used to create a second cohort to attend the Canadian Indigenous Languages and Literacy Development Institute (CILLDI) program.

The third proposal, in partnership with KTCEA, supports the creation of regional kits to support Cree and Dene language development. The final submission, in partnership with KTCEA, involves creating sets of wooden building blocks for each school that colourfully illustrate culturally relevant images, syllabic symbols and their corresponding sounds.
