# Acting Superintendent appointed by the Board of Trustees

The Board of Trustees passed a motion on April 27, 2019, to appoint an acting superintendent of schools, effective immediately. The acting superintendent of schools will be announced once ministerial approval has been received. The Board of Trustees with support from the acting superintendent will continue to focus on ensuring students graduate and are successful in life. The acting superintendent of schools will work with the Board to determine the next steps towards hiring a new superintendent.

## Process for Superintendent Reviews approved by the Board of Trustees

A recommendation to adjust the process for superintendent evaluations has been approved by the Board of Trustees. The evaluation is designed to provide more insight to the Board with respect to the performance of the superintendent, while also allowing the superintendent to more closely highlight the accomplishments relative to Policy 12 Appendix B – Superintendent Performance Assessment Guide. Key points for performance reviews include:

- A standing committee is set up to complete performance reviews.
- Following the annual evaluation, there will be three performance reviews over the school year, the last of which is to be completed in August, prior to the next annual evaluation.
- An external consultant to be hired to facilitate the performance reviews.
- Members of the Superintendent Performance Review Committee to be appointed annually at either the organizational meeting or after each annual evaluation.
- A performance review is based on growth areas as identified at the annual evaluation which is completed by the entire Board and Superintendent,

The recommended changes were developed by the adhoc committee consisting of Ward 2 Trustee Cathy Wanyandie, Ward 7 Trustee Robin Guild and Ward 8 Trustee Loretta Gladue. #### Treaty 6 and NSBA conference featured in the Board Chair Highlights



Board Chair Maddy Daniels started out by discussing the Think Indigenous International Education Conference March 20-22, 2019 in Enoch Cree Nation <a href="http://www.thinkindigenous.ca/">http://www.thinkindigenous.ca/</a>. While attending the conference, Daniels talked about a powerful film she watched called Pow Wow at Duck Lake <a href="https://www.nfb.ca/film/powwow at duck lake/">https://www.nfb.ca/film/powwow at duck lake/</a>.

Board Chair Daniels attended the National School Boards Association Conference from March 30 – April 1, 2019. She shared resources touching on subjects such as teachers guide to trauma, leadership, finding your passion and high poverty schools versus high-performance schools. She also attended sessions about literacy and

initiative overload for teachers. The literacy session talked about ensuring all students are reading at grade level by grade 3. With respect to initiatives, Daniels said the session explained school boards should have all programs channeled into a maximum of three initiatives.

#### **Education Service Agreements and Viability Study Updates featured in Superintendent Highlights**

In the latest edition of the Superintendent Highlights, NSD continues to work with Kee Tas Kee Now Tribal Council, Mikisew Cree Nation and Bigstone Cree Nation on developing education service agreements.

On April 15, 2019, the division met with the casework manager for Bigstone Child and Family Services regarding the attendance of children in care and kinship care at school. The meeting was productive and further conversations will be taking place between NSD and Bigstone.

The Board was informed about updates to the viability studies for Pelican Mountain School and Calling Lake Outreach School. For Pelican, the community population is 156 (35 school age students) instead of 68 and the school bus riding time to another school is 2.2 hours instead of 1.2. At Calling Lake Outreach School, the number of students have been changed from one to three.

On April 8, 2019, NSD met with the Urban Rez Society to discuss a student symposium in the fall of 2019. ## Land-based Learning, Numeracy and CTF/S Pilot Program highlighted in Area 1 Associate Superintendent's Report



Associate Superintendent Shelley Willier shared information about land-based learning, numeracy and the Career and Technology Foundations and Study Pilot Program in her latest report to the Board. In February and March, NSD hosted engagement dinners in Area 1 schools (Bishop Routhier School, Gift Lake School, Grouard Northland School, Hillview School, Paddle Prairie School, Susa Creek School) to discuss land-based learning. Each school received a grant to enhance land-based learning and NSD wanted input from parents and community members.

Since the month of March, Math/Numeracy Nights have been taking place in Area 1 schools. The purpose of the events is to share NSD's math and numeracy initiative with parents and families and enjoy hands-on math activities. #### **Transportation Report**

Transportation Manager Susanne Jones provided an overview of transportation in NSD. The department manages 53 school buses that service 30 divisional bus routes. They also oversee 42 fleet vehicles used by division staff. To enhance the safety of NSD student and staff using fleet vehicles, NSD is piloting ten GPS systems equipped with work alone satellite communication.

The department implemented a new route system called Transfinder. With access to the student information system, the department is able to map the students at their home and ensure all NSD students have access to transportation. To help aid with route designs, NSD is going to be educating families about pre-registering for the bus.

Jones then informed the Board of changes impacting school bus drivers. Effective March 1, 2019, standardized entry-level training is mandatory for all new Class 1 and 2 commercial drivers, along with the S Endorsement (School Bus Driver Improvement Program) for all school bus drivers. Jones said the department was successful in getting all the regular school bus drivers, contract bus drivers and some spare drivers caught up with their S Endorsement training prior to the deadline. He attended the College of Alberta Superintendents (CASS) First Nations, Metis and Inuit Education Gathering April 10-12, 2019. At the gathering, Anderson was able to view Métis education resources developed by the Rupertsland Institute. He said Rupertsland, who is currently developing curriculum on the history of the Métis, would be interested in working with NSD schools.



Ward 10 Trustee Jules Nokohoo attended the Athabasca Tribal Council Land-based Learning and Language Conference in Fort McMurray March 26-28, 2019. On April 15, 2019, Nokohoo introduced the Red Cross to Father R. Perin School Principal Bernard Woodfine to discuss student participation in Janvier's Missing Maps project. Students in grades 7, 8 and 9 have expressed interest and will begin working on the project in May.



It was a busy March and April for Ward 11 Trustee Karen Telford. A few dates of note include:

- On March 12, 2019, met with the Métis Settlements General Council Executive.
- On March 19, 2019, attended a professional learning session on Métis education programming.
- On March 26, April 11 and 15, 2019, participated in Board Advocacy Committee meetings.

Upcoming, Telford will be visiting J.F. Dion School to help with land-based learning teaching.
